**Staff Reports.** Bill Harper reported that during the recent power outage on June 29<sup>th</sup> caused by a severe storm, he and John Hodges worked around the clock keeping the lift stations pumping. He stated that the electricity went off Friday evening around 7:30 p.m. and did not come back on until Sunday evening. He and John took the generator to each lift station in four-hour intervals and only took turns going home for approximately four hours each. He thanked the Board for the new generators and stated that it was the first time in the 21 years of working here that he had a new piece of equipment he could rely on, and it made his job easier and it was greatly appreciated.
