REPORTS, QUESTIONS & DISCUSSIONS:

Police and Municipal Staff Report. Chief Arthur reported: There have been 6 property retrievals from 6 burglaries.

According to the Chief's feedback, the community feels that schools in Winfield are safer than most other places in the country. All the principals work well with our police force. Officers have had 60 hours of active shooter training and certified equipment guarantees greater success. Winfield's Police Department has trained harder and they try harder.

Chief Arthur introduced and praised Winfield's newest police officer, Devin Weis who comes highly recommended by several different agencies.

Police and Municipal Staff Report (Cont'd)

The Mayor reported: The water fountain has been installed at the new shelter beside the Community Center, the dog bowl portion of the fountain is not working properly but parts have been ordered to fix it.

A cooling station has been set up by 911 at the Community Center due to power outages after the storm.

The 2nd Annual Winfield Watersports weekend went well and had more participation than last year.

The Contractor walk through at the SBR plant was conducted: There were some gutter leaks; some pads around the press still to be installed; some equipment is not talking to each other and according to Citco Water, a wire has not been hooked up correctly. The equipment room is too warm and an AC was ordered in December but hasn't come in yet. If we downsize by ½ ton from the AC that was originally ordered, it may be available sooner.

Wastewater System/Treatment Plant Report.

Dustin Moses reported on the work of the maintenance crew in the absence of Ritchie Ferguson who is attending management classes.

Court Case Against Officer William Bogel. Officer Bogel owes the City of Winfield \$12,933.75 for breach of contract. He wants to settle for \$5,000. Kevin Karnes moved to counter with \$10,000. Motion carried.
