#### MINUTES

Hearing no objections, the minutes of October 13, 2020 were approved as presented.

## FINANCIAL

**Bill Approval.** The bills paid for the month of October in the amount of \$ 99,660.79, pass as presented.

## REPORTS

**Chairman – comments/reports.** Mayor Barrett stated that due to October's results, the aerator will be repaired when it is necessary. The plant is currently saving money on electricity by the aerator being down. Mayor Barrett reported that the guys have been busy with stormwater, water leaks, and barriers for the generator.

**Staff report.** Bill Harper, Wastewater Plant Manager, reported that the ammonia reading for the month of October was 0.13 mg/L. Bill Harper stated that the guys have worked in the manhole on Countryview and replaced 60-80' of 6'' terracotta on the sewer line at Bridge Street.

# UNFINISHED BUSINESS

**Thrasher Engineering's progress report on the new wastewater plant.** Mr. Corey Smith of The Thrasher Group stated progress includes SBR 2 Tank and digesters long with Post EQ Tank have been poured, striping forms, equipment being received daily, Hayslett Construction is continuing to work on electrical installation components. Electrical Services installed the first week of December; the timeline for startup end of this year, January timeframe to get everything turned on and started up.

**MS-4 Program.** Mr. Corey Smith of The Thrasher Group reported that Winfield Sanitary Board received a violation for missing public education information on the website. A fine was not associated with the violation, however; a letter needs to be mailed tomorrow, and updates will need to be made to the website. Corey Smith has drafted a letter and presented suggestions for the required public education information that will need to be added to the City's Website.

**Paul's Place Consider Tap Fee Change.** Mr. Tim LaFon stated that the Ordinance is perfectly clear, the Board cannot wave for some and not others. No Motion.
