- 1. Two (2) sets of construction plans if permit is for new structures, additions, residential work (decks, garages, fences, fireplaces, pools, water heaters etc.), renovations (garage conversions, basement finishing's, kitchen expansions, reroofing etc.), electrical, plumbing and HVAC systems.
- 2. Site plan showing location of proposed structure or other excavation on lot, distances from all lot lines, location of any existing structures on lot, proposed parking, proposed sanitary sewer tap, location of storm sewer tap for downspouts and driveway drainage.
- List of all contractors and sub-contractors. (Contractor Licenses are issued to assure that the contractor hired is licensed by the State of West Virginia and the City of Winfield and has the proper insurance coverage to protect both the citizens and contractor's employees.)
- 4. Site Plan Application Site Plan approval is required prior to the issuance of a building permit for developments, new structures, enlargement of existing structures, signs, parking lots, or other physical improvement (Excluding reroofing, screening or enclosing existing porches, building a sidewalk or patio, etc.).

Property owner is solely responsible for knowing the location of their property lines and/or having a survey plat completed by a licensed surveyor. The city does not survey property nor maintain records of property surveys.
