Mayor Randy Barrett called the regular monthly meeting of the Winfield City Council to order on December 12, 2017 at 6:00 p.m. at Winfield City Hall, 3426 Winfield Road, Winfield, WV.

<u>Public and Guests</u>. Jim Winter and Gary Jarvis were present to express their thanks for the City of Winfield permitting the West Virginia Drag Racer Hall of Fame to be housed in the Winfield Municipal Building. They gave a yearly summary of what had been accomplished and stated that the first event attracted 155 cars and the ribbon cutting event drew 240 cars. Jim Winter presented a plaque to Mayor Barrett for his help and cooperation in establishing the Hall of Fame.

Approval of Minutes. Hearing no objections or questions, the minutes of the October 10, 2017 Meeting were approved.

Police and Municipal Staff Report: Police Chief, Eddie Starcher reported that the hiring process was on going to replace the recent vacancy in the Police Department. He also noted that a recent bomb threat at Winfield High School, The Technical Center and Hurricane High School was under investigation.

Mayor Barrett stated that after negotiations, the old grocery store on Rt. 817 is to be demolished and a new building erected in its place.

The Mayor announced that bids would be going out soon on the proposed boat ramp. He said that the bank work will be done first and the contractor won't be allowed to go into the river before May 1st due to the mussels.

The Mayor noted that the Christmas party for City workers would be held on December 21st at 1:00 at the Community Center.

Mayor Barrett said that the recent Putnam County Chamber's Business before Breakfast function at the Municipal Building went very well with about 32 in attendance.

Mayor Barrett reported that The Thrasher Group was tweaking the layout of the new sewer plant and that next month they were expecting to go before the WV Dept of Environmental Protection for approval and funding.

<u>Wastewater System/Treatment Plant Report:</u> John Hodges reported that the ammonia reading for December was 21.2 mg/L. He said that last year at this time, the reading was 28.7 mg/L.
