Items required with application:

1. Two (2) sets of construction plans if permit is for new structures, additions, residential work (decks, garages, fences, fireplaces, pools, water heaters etc.), renovations (garage conversions, basement finishing's, kitchen expansions, reroofing etc.), electrical, plumbing and HVAC systems.
2. Site plan showing location of proposed structure or other excavation on lot, distances from all lot lines, location of any existing structures on lot, proposed parking, proposed sanitary sewer tap, location of storm sewer tap for downspouts and driveway drainage.
3. List of all contractors and sub-contractors. (Contractor Licenses are issued to assure that the contractor hired is licensed by the State of West Virginia and the City of Winfield and has the proper insurance coverage to protect both the citizens and contractor's employees.)
4. Site Plan Application – **Site Plan approval is required prior to the issuance of a building permit for developments, new structures, enlargement of existing structures, signs, parking lots, or other physical improvement (Excluding re-roofing, screening or enclosing existing porches, building a sidewalk or patio, etc.).**

Property owner is solely responsible for knowing the location of their property lines and/or having a survey plat completed by a licensed surveyor. The city does not survey property nor maintain records of property surveys.

The owner of this property, building and the above-signed, do hereby covenant and agree to comply with all the laws of the State of WV and the ordinances of the City of Winfield pertaining to building, and to construct the proposed buildings, renovations, repairs, remodeling, or excavation in accordance with the plans and specifications submitted herewith, and in accordance with building codes adopted by the City of Winfield, and certify that the information and statements given on this application, drawings and specifications are to the best of their knowledge true and correct. All permits are subject to the approval of the Building Department. According to West Virginia Legislative Rules, Division of Health, Title 64, Series 63, 1998, Article 10.1.a it is the responsibility of the Owner to ensure that "each building or other man-made structure he or she owns is inspected for the presence of asbestos by a licensed asbestos inspector prior to any renovation or demolition activities." Asbestos removal requires a separate permit and disposal. The above signed hereby declares to be legally authorized to submit plans and obtain permits for the above-stated location, owner or contractor.
